**RE: Action needed to prevent Medicare payment cuts and maintain access to specialty care**

Dear Leader Schumer, Leader McConnell, Speaker Pelosi, Leader McCarthy, and Leader Hoyer:

Thank you for your leadership and your tireless efforts to sustain access to specialty care during the ongoing public health emergency (PHE). The Alliance of Specialty Medicine (the “Alliance”) represents more than 100,000 specialty physicians and is dedicated to the development of sound federal health care policy that fosters patient access to the highest quality specialty care. As patient and physician advocates, we write to urge that Congress act before the end of the year to prevent significant Medicare pay cuts, which will impact many physician specialties effective January 1, 2022. Specifically, we request Congress **extend critical financial relief to physicians facing the looming threat of Medicare conversion factor cuts and Congressionally-mandated sequestration cuts to payment for services provided to Medicare beneficiaries.**

The Alliance appreciates the action Congress took in the *Consolidated Appropriations Act, 2021* to modify the Medicare Physician Fee Schedule (MPFS) final rule by providing a 3.75% increase in MPFS payments for calendar year (CY) 2021 to mitigate the impact of budget neutrality cuts resulting from changes to the codes for office and outpatient evaluation and management services. This 3.75% pay increase is set to expire on January 1, 2022, at the same time that the 2% Medicare sequestration payment cut will be reinstated. Further exacerbating the situation, the Congressional Budget Office (CBO) estimates that the

*American Rescue Plan Act* will trigger the statutory Pay-As-You-Go Act of 2010 (PAYGO) and mandate Medicare spending reductions of an estimated 4%, or \$36 billion, estimated to take effect in January 2022. Therefore, while still in the midst of a PHE, these policies will collectively subject specialty physicians to multiple layers of Medicare cuts in 2022, notably:

- Expiration of the 2021 3.75% MPFS CF increase;
- 2% sequestration cut; and
- 4% PAYGO cut.

We are deeply concerned that these steep cuts could have serious financial consequences for physicians who are already under financial distress due to the sustained COVID-19 pandemic.

Thank you for your serious consideration of our request. We look forward to working with you to prevent these cuts and preserve Medicare beneficiaries' timely access to specialty care.
